The sensing line is connected to the fire protection system between its respective pump discharge check valve and the discharge control valve (E and F) The size of the sensing lines shall be a minimum of 1/2-inch and must be of non-corrosive metallic pipe or tube (brass, copper, stainless steel) Galvanized pipe is not corrosion resistant
