What if my child is not picked up? If your child is not picked up by a relative or friend, s/he will likely be placed in an emergency shelter through the county Child Protective Services (CPS) agency (Welfare & Institutions Code Secs 300(g) & 306) What if my child goes to CPS? If your child is brought to CPS, act as quickly as possible:

Can I give POA over my teenage child to them or can I give POA for a younger child to an older child? No You can give POA to any person over the age of eighteen (18) but you cannot give POA to the child that is the subject of the POA or to an older sibling, that is less than eighteen years of age, for a younger sibling
